2. RULES AND REGULATIONS

Enclosed is the updated Information Bulletin of the Sport Excel Swimming Circuit for your information.

Kindly take note of the following:

- Pursuant to Rules 2.1b, and 2.1c, National and Foreign Swimmers are not eligible for any medals, awards or incentive payments and they shall swim as EXHIBITION (EXH). Please mark them as EXH in the Hytek entry file;
- Clubs must identify Foreign Swimmers and check the home country they are representing in the Hytek file. There is a maximum of 3 Foreign Swimmers permitted in each event per age group per gender;

- c. Clubs may enter a maximum of 3 Reserve Swimmers in the Entry Submission, of whom are listed in the List of Qualifiers. The final confirmation shall be informed once a vacancy is confirmed.
- d. Should any of your qualified Swimmers decline the offer to swim an event, please notify us immediately so that the next Reserve swimmer can be advised promptly. NO notice of withdrawal from a Swimmer including Reserves shall be deemed as a positive confirmation of participation.
- e. Due to the inconsistencies in registration and display of Swimmers' names in the consolidated results, please notify us of any duplication of names. As per Rule 8.8.2.1e, each Swimmer must represent the SAME Club in all of the Circuit competitions – Legs 1 and 2, and the Grand Finals;
- f. Due to time constraints, the Top 30 Swimmers in the 400m Freestyle and 400m Ind. Medley events, and the Top 20 Swimmers in the 800m and 1500m Freestyle events shall qualify to the Grand Finals;
- g. 50m and 100m events and 200m Freestyle and 200m Ind. Medley events shall have A / B Finals. 400m Freestyle, 400m Ind. Medley, 800m and 1500m Freestyle shall have only an A Final.
